Registration For Course and Application Fee

The process of admission to C-DAC's Diploma course begins with Registration of prospective candidates on the C-DAC website, www.cdac.in/dasdm. Upon registering, candidates will get their form number that can be used to log in and fill the CET application form online. The form number must be remembered by the candidate as it will be the reference number and login ID of the candidate during the whole admission process. Read carefully the instructions on the C-DAC website while filling the online registration and application forms.

The candidate will get the Form No. and password in his mail id. Once candidates have completed registration, the next step is to log in and fill the CET application form.

After filling the application form, candidates have to upload their passport size photograph. The next step is payment of CET application fee that may be paid online or by demand draft. The details of payment are given in the section Application Fee.

The steps successfully completed in the application process are shown with a tick-mark on the main menu of the online application. Candidates facing any issues during the downloading of form or any other query online registration and application may contact C-DAC ACTS, Pune, through phone (020-25503104/143) or e-mail (actssupport@cdac.in).

Application form can be filled online from the website acts.cdac.in. The application fees of Rs.600/- (Rupees Six Hundred only) is to be paid through online payment gateway using the credit card or debit card or internet banking.

Online: The application fee can be paid using credit/debit cards through the payment gateway that will be opened upon clicking the 'Online' option of the 'Make Payment' step. Candidates are advised to follow the instructions/steps given on the payment gateway, and also print/keep the transaction details for their records.

On accepting the application fee at C-DAC, the 'Make Payment' step on the main menu of the online application will be tick-marked, and the status of payment will be updated on the 'Status Check' menu.

Important Note: The centre selected by the candidate while filling the application form for appearing in CET will also be the final centre to undergo the DASDM course.

Course Duration, Eligibility

Course Duration:

The DASDM course is of Nine months duration (6 months training + 3 months internship) with the course syllabus being distributed in four terms.

Eligibility:

Minimum eligibility criteria to appear for admission to DASDM course is as follows:

- Graduates in Science (eg. BCA or B.Sc. in Computer Science, IT and Electronics etc)
- Graduates in Mathematics or allied areas (e.g. Statistics, Applied Math)
- Graduates in Physics or Computational Sciences / Graduates in Computing
- The candidates must have secured a minimum of agregate 50% marks in their qualifying examination

Course Pre-requisites: Sound knowledge of Computing Fundamentals and Fundamentals of Programming.

Candidates who have appeared for the final examination of their qualifying degree in 2016 will also be considered for admission to the above courses. By qualifying in C-DAC's Common Admission Test (CET) of Feb 2017, these candidates can apply for provisional admission subject to the condition that:

- (a)All parts of their qualifying degree examination shall be completed by the date of joining the course, and
- (b) Proof of having passed the qualifying degree with at least the required minimum marks shall be submitted at C-DAC by 30th April 2017.

Important Note: Candidates are required to ensure that they meet the eligibility criteria of the courses for which they are applying. In case a candidate is found to be not eligible during any stage of the admission process or course delivery, his/her admission will be cancelled with immediate effect and he/she will not be able to attend any further classes.

Course Fees

Course Fee:

The total course fees of DASDM course is Rs. 80,000/- plus taxes extra as applicable by Government of India.

The fees of DASDM course is to be paid in four installments as provided in the table below:

The student has to pay the admission fees and Tuition fees using online payment gateway through Debit or credit cards or internet banking.

The course fee includes the cost of course delivery, computer lab usage, examinations, final mark-list, certificate and placement assistance provided at the training centre. Candidates may take note that no cheque or cash or DD will be accepted towards payment of any installment of fees.

The Admission fees and Tuition fees once paid shall not be refunded in any circumstances.

Important Note: : Service tax as applicable in Februrary 2017 will be calculated on the total fees of Rs. 80,000/-. Service tax in December 2016 is 14% Swaccha Bharat cess 0.5% and Agriculture Cess 0.5%.

Common Entrance Test (CET)

The admission to the DASDM course is through a Common Entrance Test (CET). The syllabus of the CET comprises of the following:

Computing Awareness (40 questions)

Evolutions of computers, Computer generations, Computer organization, Primary and Secondary storage, Input-output devices, Computer software, Operating systems, Data communications and computer networking, Multimedia, Classification of computers, Algorithms, Flow charts, Fundamentals of Programming, Utility Software, Computer Security, etc.

Functional English (20 questions)

Mathematical Aptitude (20 questions)

Reasoning (20 questions)

CET Admit Cards

The Admit cards can be downloaded from the website. The admit cards can be downloaded from the website on 09th February, 2017. The candidates will not be able to download the Admit Cards, if their payment have not been received at the C-DAC training Centre. No candidate will be permitted to appear in CET test without a valid Admit Card. The Admit Card should be presented to the invigilators/ officials for verification.

Result

CET results will be published on the C-DAC website on 16th Feb, 2017. In order to be considered for admission to the course, a candidate's name must appear in the rank-list and also satisfy its minimum eligibility criteria.

The result of the CET will be published centre wise. Students will be only eligible to take admission in the centre where he has applied at the time of filling the application form. The Candidate will be ranked based on the score he / she have secured in CET.

Document Verification & Interview

At the time of Certificate Verification, candidates need to show their photo identity cards for identification, submit three passport-size colour photographs and photocopies of qualifying degree certificate or provisional/passing certificate from the university. The original certificates should be presented for verification at the time of registration.

Candidates who do not have their qualifying degree certificate (including students who have appeared for the qualifying examination and awaiting results) will be given provisional admission on submitting (at the admitting centre) the proof that they have already taken all the examinations for their qualifying degree at the time of registration. These students will have to submit (at the admitted centre) the proof of having passed the qualifying degree with the required minimum marks by 28th Feb 2017 to confirm their admission.

Important Note: Candidates who are provisionally admitted as students but are unable to produce the proof of qualification by 31st April 2017 will have their admissions cancelled. They will not be eligible for any refund.

Last date of payment of Admission Fees

The candidates appearing in the CET ranklist for a training centre shall pay the Admission Fees of Rs. 10,000/- (Rupees ten thousand only) and the Tuition fees of Rs. 25,000/- (Rupees Twenty Five Thousand only) i.e. sum total of Rs. 35,000/- (Rupees Thirty Five thousand only) plus all taxes as applicable by Government of India for confirmation of the seat in the training centre. The payment of the course fees of Rs. 35,000/- plus taxes shall be made through online payment using Debit or Credit card.

The payment shall be submitted online by 28th Feb 2017.

Important Note: Candidates will be permitted to select only one training centre at the time of filling in the application form. They cannot opt/apply for any other centre than what they had initially selected under any circumstances.

A candidate has to select the training centre of his choice as desired during application form. Under any circumstance, a candidate will not be allocated another centre, which was not selected during the application stage.

Upon payment of full fees, the selected candidates will be enrolled as C-DAC students at the respective training centres. They will get a student identity number.
